General Information and Conditions

For more information on this cruise, contact Golden Frontier at (618) 234-1445. Rates include ocean transportation, accommodations, all meals, all services aboard ship, port taxes and roundtrip airfare between St. Louis/Chicago/Kansas City/or Indianapolis and Seattle, Washington. Other major U.S. city departures available. Rates do not include shore excursions, laundry or valet services, or any items aboard ship of a personal nature such as wines, liquors, beverages, and gratuities. Rates are in U.S. dollars, per person, based on double occupancy of accommodations selected, unless otherwise noted.

Travel Documents: United States and Canadian citizens must have a valid Passport. All others must have valid passports and necessary visas. There can be no refund if a passenger is denied boarding by local immigration officials for lack of proper documents.

Baggage Handling: There are porters at the airport and pier, but hand luggage, valuables, breakable items, and medicines must be hand carried by the passenger. Norwegian Cruise Line and Golden Frontier cannot accept responsibility for any personal items nor for any luggage not under Norwegian Cruise Line's direct care on board.

Baggage Responsibility: Norwegian Cruise Line and Golden Frontier are not responsible nor liable for damage, loss, or theft of baggage or personal effects. Claims for baggage loss or damage must be made in writing to the Chief Purser or Pier Manager prior to leaving disembarkation pier. Norwegian Cruise Line liability for such claims is limited to \$150.00 per person.

Cancellations and requests for refunds **must be submitted in writing** to Golden Frontier. All documents must be returned before a refund can be processed. **Once application is made, all cancellations are subject to a non-waivable \$100.00 per person cancellation fee.** Written cancellations received in Golden Frontier's office 100 to 86 days prior to departure forfeit 25% of total payments, plus \$100. Cancellations 85 to 71 days prior to departure forfeit 50% of total payments. Cancellations 70 to 41 days or less prior to departure forfeit 75% of total payments. Cancellations 40 days or less prior to departure forfeit 100% of total payments. Golden Frontier shall not be obligated to refund any portion of a fare for a passenger who must leave the cruise prematurely for medical or other reasons. There are no refunds on unused tour features. The cruise ticket is valid only for the named passenger and may not be sold or transferred. **Optional trip cancellation and baggage insurance** is available with separate application. Insurance can cover cancellation of your reservation prior to departure, leaving the tour after departure, baggage loss, and some medical coverages. A brochure and application for insurance will be sent to all applicants or is available by calling the Golden Frontier office. Airline tickets are non refundable once purchased.

***NON PERFORMANCE INSURANCE.** Payment from cruise lines is required months prior to departure and often includes air line tickets with their contract.
